Trade-In & Buyback Program – Terms & Conditions

Thank you for participating in Sentinel Supply LLC's ("Sentinel Supply") Trade-In & Buyback Program. To ensure a smooth and efficient process, please review and acknowledge these terms and conditions.

Trade-In Program Terms & Conditions

1. Trade-In Timeline & Requirements

- **Trade-In Deadline:** All non-duty essential firearms must be traded-in within five (5) business days of accepting the trade conditions.
- **Magazine Requirements:**
 - Duty pistols must be accompanied by three (3) magazines each.
 - Rifles must include one (1) magazine each.
 - A \$25 deduction will be applied for each missing magazine. Agencies must indicate the number of magazines for each firearm on the Agency Trade-In Worksheet.
- **Transition Period:** Agencies have 30 calendar days from the receipt of new firearms to deliver their trade-in firearms to Sentinel Supply.

2. Shipping & Delivery

- Agencies are responsible for shipping or delivering trade-in firearms to:

- Firearms must be shipped via USPS Two-Day Priority Mail with Adult Signature Required.

3. Firearm Condition & Trade Value

- Agencies are responsible for maintaining the condition of trade-in firearms during the transfer period.
- Any damage or decline in condition may result in a reduction of trade-in value.
- **Loaded Firearms:** Any firearm shipped or delivered loaded with live ammunition will be reduced to \$0.00 trade value, and the agency will be immediately notified due to the extreme safety risk.
- **Damaged Firearms:** If a firearm's condition is not fully disclosed on the Agency Trade-In Worksheet, a minimum 25% reduction in trade value will apply.
- **Non-Functioning Firearms:** Firearms that are non-functional will be treated as parts and be credited at a minimum of 75% less than their full trade value.

4. Trade Credits & Ownership

- Trade-in credits will expire 365 days (one year) from the date of issuance.
- Sentinel Supply reserves the right to retain any firearms that have been negotiated for trade-in credit with the agency.

5. Buyback Period & Process

- **Buyback Period:** Authorized Officers have five (5) business days from the date the trade-in firearms become the property of Sentinel Supply and Sentinel Supply issues an invoice to the Officer for the firearm(s) to complete their purchase.
- **Buyback Pricing:** Special buyback prices apply only during the five (5) business days buyback period and are available exclusively to sworn officers currently employed by the trade-in agency.
- If full payment by the Officer is not received within that five (5) business day buyback period, the corresponding purchase agreement shall be deemed null and void, and Sentinel Supply reserves the right to offer the firearm for sale to the Officer or another party at its sole discretion for a different purchase price.

6. Buyback Pricing Structure

- Agency Duty Pistols: Cost + \$35.00 + Taxes
- Agency Duty Rifles: Cost + \$45.00 + Taxes
- Agency Duty Shotguns: Cost + \$35.00 + Taxes
- Agency Confiscated Firearms: Cost + Market Value
